We held our second annual Creation Care/Climate Justice Work Day at Carol City United Methodist Church on Saturday, June 15th. In spite of the rain, we had a full day of digging, planting, mulching, and pruning. Our District Superintendent and several members of the clergy in the South East District were there supporting us and working alongside UWFaith members and community partners. This is important work that is part of our UWFaith Climate Justice campaign.

The FL Conference UWFaith's 2024 Mission u was held in July with 140 people in attendance at the in-person event and 20 participating in virtual Mission u. We experienced inspiring curriculum and keynote presentations about drawing closer to God and "Living the Kingdom," while also enjoying a number of activities and the warmth of our sisterhood. There were many in attendance from the South East District, including those from the former Atlantic Central District who are now in the South East District. It was especially wonderful to meet together face to face and share with one another during the district gathering.
